

**COUNTY OF TWO HILLS NO. 21
IN THE PROVINCE OF ALBERTA
BYLAW NO. 08-2022**

A BYLAW OF THE COUNTY OF TWO HILLS NO. 21 TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE COUNTY OF TWO HILLS NO. 21 FOR THE 2022 TAXATION YEAR.

WHEREAS the estimated expenditure for the County of Two Hills No. 21 adopted budget for the year 2022 is \$21,603,552 and,

WHEREAS the Total Assessed Value of Taxable Property within the County of Two Hills No. 21 as shown by the assessment roll is as follows:

AND WHEREAS it is estimated that the sum of \$9,200,763 will be collected from sources other than the current levy, thus leaving the amount to be levied as \$9,483,762. Unfunded Amortization \$2,919,027.

NOW THEREFORE by virtue of the powers provided in accordance with the Municipal Government Act, being Chapter M-26, Revised Statute of Alberta 2000, as amended, the Council of the County of Two Hills No. 21 enacts as follows:
