#### RCMP Delegation

Inspector Glen De Goeij, Inspector Brian Sutherland, Supt. Dave Mitchell, Sgt. Ray Campbell, Two Hills RCMP and Staff Sgt. Brain Quist, St. Paul RCMP, and Supt. Ken Turner were invited into the Council Chambers and informed Council on staffing/manpower issues, the Two Hills RCMP building, Annual Performance Plan and Enhanced Police Service.

The following information was also provided:

- There is currently no funding available for a new building from the Federal Government.
- There is a staffing/manpower issue; however there will be no staffing increase in the near future.
- Enhanced Policing buy the service of a police person to work out of the Two Hills Detachment at \$125,000 per year and minimum three year contract. Revenue will be generated back into the County. A member will be brought into the Division to do the policing.
- Special Initiative Provide the detachment with a certain amount of funds for required initiative of the County. Revenue will also be generated back to the County.
- The above positions are to protect the infrastructure and provide safety within the County.

There being no further questions or comments, Inspector De Goeij, Inspector Sutherland, Supt. Mitchell, Supt. Turner, Sgt. Quist and Sgt. Campbell thanked Council for their time and left the Council Chambers.

# Proposed Facility in TH

The CAO informed Council that the old hospital building in the Town of Two Hills, (BDC) has been deemed uninhabitable and is slated to be demolished. The Town of Two Hills and County have been approached by the Provincial Government (owner), with a proposal that we share the cost of building a new facility to replace the old building.

It was the consensus of Council to support the letter submitted to Hon. Danyluk, Minister of Infrastructure regarding the 'old hospital' dated December 22, 2010, issued by the County Reeve and Town Mayor.
