# Historical Site at Shandro

The CAO informed Council that the St. Mary's Russo Orthodox Church at Shandro has informed Administration that only Provincial Historic Resources and Municipal Historic Resources that are listed on the Alberta Register of Historic Places are eligible to receive conservation funding assistance.

The St. Mary's Russo Orthodox Church at Shandro is requesting that the County designate this Church as a historic site within the County of Two Hills.

The St. Mary's Russo Orthodox Church at Shandro will restore the church by painting the exterior, replacing shingles and repairing window structures.
