It was the consensus of Council that Administration bring back the Distribution of Recreation Funds Policy ADM-REC-1 for review at the next Policy Meeting.

The CAO informed Council that CCI Wireless is currently working to update coverage maps for Alberta, showing areas of un-served and under-served high speed internet service.

Industry Canada identifies the County as having robust service (consistent speeds of greater than 5 Mbps), however, based on feedback from CCI customers, County citizens, businesses, and wireless industry information, CCI Wireless is confident that this is not the case.

The County has been identified by CCI Wireless, as an area in Alberta that could benefit from the Connecting Canadians Program. Industry Canada maps could form part of the basis for allocation funding under the program, with the County's assistance in identifying the areas of un-served or under-served.

CCI Wireless is requesting a letter of support for inclusion in their application for Connecting Canadians grant. Noting this letter of support does not constitute a commitment by the County, although they would welcome County involvement in the project. If successful CCI Wireless would provide the 50/50 grant contribution requirement.
