#### Two Hills Medical Clinic

An agreement for the New Medical Clinic was reviewed, having the same requiring ratification by the Councils of each municipality.

Mayor Henry Neufeld, Deputy Mayor Gerren Saskiw (via teleconference), and Councillor Bruce Gray, Councillor Willie Babiuk, Councillor Sonny Rajoo, and Chief Administrative Officer Elsie Howanyk from the Town of Two Hills were invited into the Council Chambers to discuss the New Medical Clinic Agreement.

Dr. Abdul Satar, Satar & Van Wyk Corporation was invited into the Council Chambers.

On conclusion of discussion, review and amendments made to the New Medical Clinic Agreement, all parties involved were in favor of the said agreement.

Construction – Twp Rd 534 & Rge Rd 140

The CAO informed Council that as discussed at the Public Works Meeting of September 3, 2015, the Public Works Supervisor informed the Committee that the County of Minburn has requested that while the County of Two Hills is constructing Twp Rd 534 and Rge Rd 140 the County of Minburn corner be upgraded.

Hairy Hill Community Hall Playground

The CAO informed Council that a request has been received from the Hairy Hill Playground Project Coordinator requesting reimbursement of the \$50.00 development permit fee for the proposed playground project and that the County of Two Hills Public Works Department undertake the chain link fence installation.

Two Hills Lions Golf & Country Club

Graders

Capital Budget - The CAO informed Council that as discussed at the Public Works Meeting of September 3, 2015, the Public Works Supervisor placed graders on the table for discussion. Quotes were received from Finning and Brandt Tractor Ltd.

It was consensus of Council that Administration provide written notice of intent to exercise its right under the Grader Buyback Agreement between Strongco and the County of Two Hills.

That the County of Two Hills purchase eight Cat 2015 160M AWD Motor Graders equipped with Weldco mastless snow wing, quick coupler, manual angle 132" dozer, and ripper/scarifier for a purchase price of \$405,000 each, with a guaranteed buy back (including attachments) of \$208,560.00, five years at 7,500 hours, F.O.B. Two Hills (2016 budget).
